Welcome to Loconoma Continuation High School.

Loconoma is a 16 – 25 student continuation high school with one classroom teacher, an off-campus administrator, and an instructional assistant who is employed for four hours each day.

The mission of Loconoma Valley Continuation High School is to provide its students with the opportunity to earn a high school diploma, by meeting their unique personal and educational needs. The student population includes 10th-12th graders who attend between the hours of 8:00 A.M. and 2:30 P.M. The students select Loconoma Valley High School for a variety of reasons. Most commonly, the students are either credit deficient, have below average basic skills, have a history of truancy or disciplinary problems, or are otherwise seeking a fresh start. Some students may have been unsuccessful for a variety of reasons in their previous educational settings, while others work or have other responsibilities, and need a more flexible school schedule than that offered at the traditional high school.

School Description and Mission Statement (School Year 2016-17)

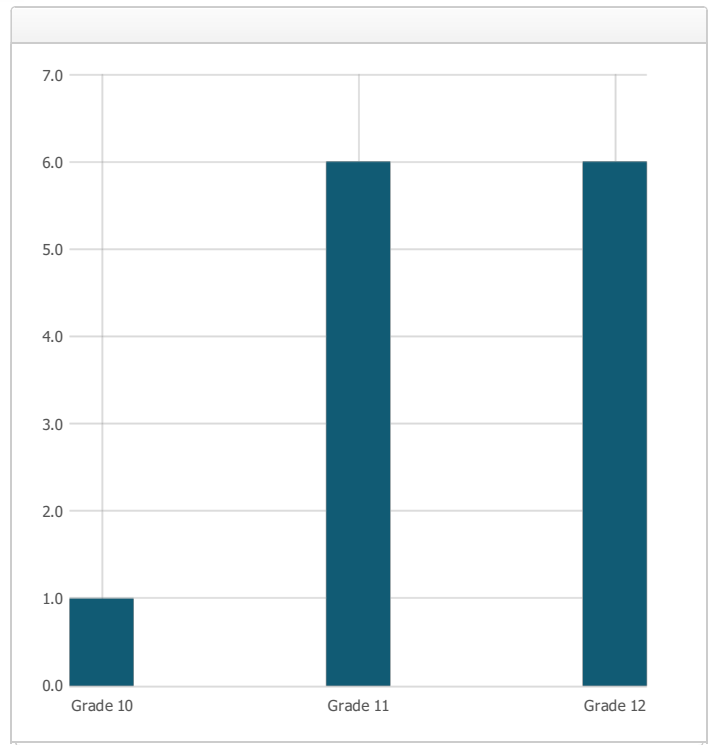

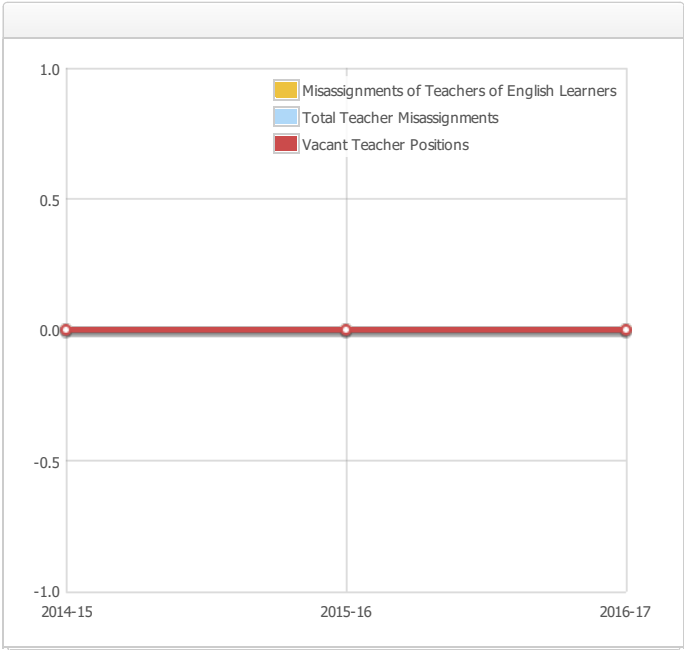
